**The researcher response to this question was “a.”** The government seeks legislative approval for virements. Virement is the movement of savings on one or more sub-heads to meet excess expenditure on another sub-head in the same vote; this is done via a Virement Warrant. Rules for virements are contained in the Appropriation Act. See Appropriation Act 2004 paragraph 3, page 3.

**Researcher Response to Peer Reviewer:** Sometimes approval is obtained before virements, sometimes it is obtained after virements. So to state flatly that executive seeks approval only after shifting fund would be misleading. If there were any answer like “Sometimes legislative approvals are obtained before funds are shifted” that would be more appropriate.

**Peer Reviewer ONE Comment:** Although statutorily the executive should seek approval before virement, this is not always the case and has been a major source of tension between the executive and legislature. A more appropriate response to this question would be ‘c’.

**The researcher response to this question was “a.”** The Budget Monitoring and Price Intelligence Unit (BMPIU) of the Presidency is working hard to enforce due process in public procurements. In the past year there has been no public information of any credible instances in which the procurement of goods and services did not follow due process. This is because before public procurement is made it must undergo due process of the BMPIU.

**Researcher Response to Peer Reviewer:** The answers and comments given in this questionnaire should be done bearing in mind the time frame for this exercise – which is 2005. So when we ask “during the last year has there been any credible reported instances ...” we are referring to 2004 fiscal year. The NPA case mentioned happened between 2000 to 2003 (the first tenor of the Obasanjo Administration). The Presidential Jet issue happened in 2006 and is still being investigated. Of course, nobody would yet give a clean bill of health to the Nigerian public procurement process but, it could be said that there is remarkable positive changes given from where we started.

**Peer Reviewer ONE Comment:** This is incorrect. There is the case of procurement of a new Presidential jet and the contract scandal at the Nigeria Ports Authority (NPA). A more appropriate response to this question would be “b.”

**Peer Reviewer TWO Comment:** A more appropriate response to this question would be “b.” Impeccable sources indicate that progress in the area of procurement can best be described as modest given the rumored corruption of the due process mechanism. Put starkly, officials of the Budget Monitoring and Price Intelligence Unit (BMPIU) are alleged to be using agents to extort money from government departments to get easy sail for their budget outlays, which are undoubtedly inflated. It is self-deluding to put too much faith in the public display of government officials since from their actual behavior (proven quest for medical care abroad, acquisition of landed property and money laundering in European and American cities) they do not seem to have a strong faith in Nigeria. More importantly, there so far has been no independent evaluation of BMPIU’s claims regarding success in enforcing due process in procurement. See for example, *Nigeria 2004 Transparency International Country Study Report*.

**IBP Comment:** IBP editors chose answer "b" because, even though the stated improvements should be recognized, the recent track record of Nigeria makes an "a" answer unlikely.

**The researcher response to this question was “a”:** Supplemental budgets are approved before the funds are expended. For instance, the \$12.4 billion required for exit payment from the Paris Club was sent to the legislature before expending it.

**Researcher Response to Peer Reviewer:** The correct situation is that in some cases the supplemental budget is approved before funds are expended, while in few cases it may not be so. So stating ‘b’ as the answer may not truly represent the situation in the country.

**Peer Reviewer ONE Comment:** This is incorrect. Some of the money had been paid to the Paris Club before the National Assembly approved the supplementary appropriation. A more appropriate response to this question would be “b.”

**Peer Reviewer TWO Comment** A more appropriate response to this question would be “b.” On several occasions, the National Assembly accused the executive of extra budgetary spending. This shows that submitting the proposal of \$12.4 billion supplemental budget to exit from the Paris Club to the legislature for approval before expending the large sum is an exception than the rule.
