(Revenue \$) Strategic Initiatives - In 2018 IBP supported special projects related to completing and implementing its new organizational strategic plan, as well as laid the groundwork for new programming on climate finance accountability and tax equity. IBP also provided support for the Fiscal Futures project, which convened global thought leaders in fiscal transparency and accountability to review assumptions, rethink strategies and imagine the future of public finance.

4c (Code:) (Expenses \$ 2,065,406. including grants of \$ 27,140.) (Revenue \$ 82,088.) Research: IBP's Open Budget Initiative is a global research and advocacy program that promotes public access to government budget information and the adoption of accountable budget systems. The initiative's flagship research product, the bi-annual Open Budget Survey, is the world's only independent, comparative assessment of the three pillars of public budget accountability: transparency, oversight and participation.
